
INSTALLATION INSTRUCTIONS



- 1. Please read and understand this entire manual before attempting to assemble, install, or operate this light fixture.
- 2. This fixture is designed for use in a 120VAC / 60Hz fused circuit. This fixture is not compatible with dimming circuit.
- 3. Some codes require installation by a qualified electrician.
- 4. This light fixture must be properly grounded.
- Make sure connections are secure using included Wago connector, crimp-on lugs or other UL approved connecting devices.
- Before installation or servicing, turn the power OFF at the circuit breaker or fuse. Place tape over the circuit breaker switch and verify power is OFF at the light fixture.
- 7. This fixture is intended to be used for general outdoor lighting in dry, damp, or wet locations. For wet locations, fixture must be mounted at least 48 inches above ground level.
- 8. MIN 90 °C SUPPLY CONDUCTORS; "LES FILS D'ALIMENTATION 90°C MIN" .



MOUNTING


1. Remove the mounting plate (D) from the back of the fixture by loosening the set screw (C) using the Allen wrench (DD). (fig.1)



- 2. Route the junction box wires through the large center hole in the mounting plate (D).
- Align the holes on the mounting plate (D) with the holes on your junction box. Use two #8 screws (AA) to secure it. Please make sure the "TOP" is upwards.(fig.2)




- Place the small sphere head of the hanger wire (E) between the back of the small groove located on the bottom of the center hole of the mounting plate (D).
- 5. Ensure the photocell (B) is facing upwards when the light fixture (A) is installed. (fig.3)








- 6. Complete the electrical connections per the Fixture Wiring section.
- CCT switch is located behind the fixture (fig. 4). Adjust the switch to desired color temperature of 3000K, 4000K, or 5000K. Note: Fixture is preset to 3000K from factory.



- 8. Once wiring connections are done, place the light fixture (A) onto the mounting plate (D). Verify the fixture is flush with the mounting surface.
- 9. Tighten the set screw (B) on bottom of the fixture (A) to secure it.(fig.5)



10. Apply a small bead of silicone (not included) per manufacturer's instruction around the perimeter of the fixture (A) where it contacts with the surface of the wall or ceiling.


WIRING

11. Restore power at the fuse or circuit breaker box.

Make all wire connections to appropriate wire. Secure with wire nuts (provided). Connect the white wire from the fixture to the white (N) wire from the

supply power source. Connect

the black wire from the fixture to



the black (L) wire from the supply power source. Connect the green wire from the fixture to the supply power source ground wire.

OPERATION

SELECTING DUSK-TO-DAWN OR SWITCH-ACTIVATED CONTROL OPTION1: DUSK-TO-DAWN OPERATION

Limited Factory Warranty

AFX Inc. hereby warranty that this fixture is free from defects in materials and workmanship when installed and used under normal operating conditions for a period of 5 years from date of shipment from factory. This warranty covers all component parts and extends only to replacement of defective fixture or components; it does not cover failure due to improper installation, misuse, mishandling or damage incurred in transit.

- (1) To enable dusk-to-dawn operation, remove the black cap cover installed on the fixture, and replace it with a clear cap cover included in the hardware kits. Note: Ensure the photocell is unobstructed.
- (2) Ensure the switch powering the outlet connected to the light fixture is turned to the ON position and leave it ON at all times to enable dusk -to-dawn functionality to operate automatically.

OPTION2: SWITCH CONTROLLED

(1) To enable switch activated operation leave the black cap cover on the photocell

CARE AND CLEANING

- 1. Shut off the main power supply before cleaning the fixture. To prolong the original appearance, clean the light fixture with clear water and a soft, damp cloth only.
- Do not use abrasive cleaners or cleaners that contain alcohol. Do not apply paints, solvents, or any other chemicals on this light fixture. They could cause a premature deterioration of the finish and may void the warranty. Do not spray the light fixture with a hose or power washer
